Secretary of the Board:

The Municipal School Board shall have the following functions:

1. Determine in accordance with the criteria set by Dep-Ed and the LGU-Itogon the Annual Supplemental Budgetary needs for the operation and maintenance of public schools within the municipality, as the case may be, and the supplemental local cost of meeting such needs, which shall be reflected in the form of an Annual School Board Budget corresponding to its share in the proceeds of the special levy on real properties constituting the Special Education Fund (SEF) and such other sources of revenue as the code and other laws and ordinances may provide;

**2.** Authorize the Municipal Treasurer, as the case maybe, to disburse funds from the Special Educational Fund (SEF) pursuant to the budget prepared in accordance with applicable existing rules and regulations;

**3.** Serve as advisory committee to the Sangguniang Bayan on educational matters such as, but not limited to the necessity of using local appropriations for educational purposes;

**4.** Recommend changes in the names of public schools within the territorial jurisdiction of the LGU for enactment by the Sanggunian concerned;

**5.** Advise/recommend to Dep-Ed on the appointments of division superintendents, District Supervisors, School Principals and other school officials;

6. The honorary members shall act as support to the board whose presence and attendance in board meetings may be required if deemed necessary;

**7.** Perform other duties and functions as mandated and prescribed by other pertinent laws, Ordinances and issuances.

This Administrative Order shall take effect immediately this 15thday of August 2013.
