AMENDING ADMINISTRATIVE ORDER NO. 04-2013-N, ENTITLED "REORGANIZING THE COMPOSITION OF THE MUNICIPAL LOCAL FINANCE COMMITTEE OF THE LOCAL GOVERNMENT OF ITOGON, BENGUET PROVINCE"

WHEREAS, there exist a Municipal Local finance Committee which was reorganized by virtue of Administrative order No. 04-2013-N issued and promulgated by the local chief Executive;
