**ADMINISTRATIVE ORDER NO. 003**

**RECONSTITUTING THE MUNICIPAL DEVELOPMENT COUNCIL.**

**WHEREAS**, pursuant to the pertinent provisions of the Local Government Code, the Municipal Development Council was reorganized by virtue of Administrative Order No. 10-13-N issued in July, 2013;

**WHEREAS**, the expiration of the term of office of all Punong Barangays last November 30, 2013 and the result of the October, 2013 Barangay Elections requires for a change of membership in the development council in as far as mandatory membership of the Punong Barangays is concerned;

**WHEREAS**, in accordance with the Local Government Code, the Department of the Interior and Local Government issued Memorandum Circular No. 2013-70 prescribing guidelines for the accreditation of Civil Society Organizations and selection of representatives to the local special bodies hence, on December 3, 2013, an assembly meeting of all CSOs was called for the purpose thus the selection of CSO representatives to the Municipal Development Council;

**WHEREAS**, in view of the foregoing developments, it is imperative to reconstitute the Municipal Development Council to include in its membership the re-elected Punong Barangays, the newly-elected Punong Barangays in lieu of their respective predecessors, and to include therein representatives from the Civil Society Organizations who were selected accordingly.

**NOW THEREFORE**, by virtue of the powers vested in me by law, I, **ATTY. VICTORIO T. PALANGDAN**, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby ORDER as follows:
