**AMENDING ADMINISTRATIVE ORDER NO. 32-13-N**

**WHEREAS**, Administrative Order No. 32-13-N was promulgated in order to carry out the purpose and objectives of R.A. 8759 as far as employment and equality of employment opportunities is concerned;

**WHEREAS**, due to the designation of Mr. Nestor Camado Jr. as Municipal Tourism Action Officer, there is a need to designate a Public Employment Service Officer in lieu of the former;

**NOW THEREFORE**, by virtue of the powers vested in me by law, I, **ATTY. VICTORIO T. PALANGDAN**, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby amend Administrative Order No. 32-13-N as follows:

**Section 1.** Ms. Jocelyn S. Ngail is hereby designated as the Municipal Public Employment Service Officer.

**Section 2.** The duties and functions of the Public Employment Service Officer as provided under Administrative Order 32-13-N, pursuant to R.A. 8759 shall remain without disregard however to the assistance on PESO matters to be rendered by Mr. Nestor Camado Jr. until such time that the new PESO-designate gets fully acquainted of her duties and functions.

**Section 3.** All Administrative Orders and/or Issuances inconsistent herewith or parts hereof are deemed repealed and/or modified accordingly.

**Section 4.** This Administrative Order shall take effect on June 2<sup>nd</sup>, 2014.
