AN ADMINISTRATIVE ORDER CREATING THE LGU PERFORMANCE CHALLENGE FUND (PCF) PROJECT IMPLEMENTATION TEAM

WHEREAS, the President's vision as espoused in the Philippine Development Plan (PDP) 2011-2016 is to achieve inclusive growth – rapid and sustained environment that creates jobs and continuously reduces mass poverty;

WHEREAS, corollary to PDP's policy on good governance is a national declaration and campaign for people's engagement in local governance thus, LGUs are encouraged to create opportunities for citizens to continuously engage with them in an inclusionary and participatory manner such as in the implementation of local government's development projects, among others;

WHEREAS, the DILG through its Performance Challenge Fund provided financial incentives to local government units that were committed in valuing the fundamentals of good governance by meeting the requirements of the Seal of Good Housekeeping;

WHEREAS, the Municipality of Itogon is among the eligible LGUs being a consistent Good Financial Housekeeping (GFH) passer for two consecutive years (2012 SGH and 2014 SGLG-SGH) to access the 2014 Performance Challenge Fund (PCF) subsidy in the amount of One Million Pesos (Php 1,000,000.00);

WHEREAS, as stated in DILG MC 2013-148 dated Dec. 19, 2013 re: Guidelines in the Implementation of the CY 2013 Performance Challenge Fund, one of the required documents in accessing the PCF is the creation of an LGU PCF Project Implementation Team;

NOW, THEREFORE, I, ATTY. VICTORIO T. PALANGDAN, by virtue of the powers vested in me by law as Municipal Mayor of Itogon, Benguet, do hereby organize the LGU PCF Project Implementation Team;
