## REORGANIZING THE MUNICIPAL HEALTH BOARD

**WHEREAS**, the major development thrust of the new leadership is social development, of which health is one of its major components;

**WHEREAS**, due to the re-assignment of National Government Agencies – Municipal based personnel, there is a need to reconstitute the members of the Municipal Health Board to spearhead and oversee the implementation of health-related plans, programs and projects and further ensure that the objectives of such are satisfactorily attained;

**WHEREAS**, the creation of the said central body as cited in the preceding whereas, popularly known as the Municipal Health Board is sanctioned by the provision of Section 102 of the Local Government Code of 1991;

**WHEREFORE, I, ATTY. VICTORIO T. PALANGDAN**, by virtue of the powers vested in me by law as the Municipal Mayor, this municipality, for reasons afore stated, do hereby reorganize the Municipal Health Board to be composed of the following with their identified functions to wit;


2. To serve as an advisory committee to the Sanggunian for and application of local appropriations for public health purposes.

3. To create committees consistent with the technical and administrative standards of the Department of Health, which shall advice local health agencies on the matters such as, but not limited to personnel selection and promotion, bids and awards, grievance and complaints, personnel discipline, budget review, operations and similar functions.

This Administrative Order shall take effect immediately upon approval.
