AN ADMINISTRATIVE ORDER REORGANIZING THE LGU PERFORMANCE CHALLENGE FUND (PCF) PROJECT IMPLEMENTATION TEAM, AMENDING ADMINISTRATIVE ORDER NO. 15-009 FOR THE PURPOSE

WHEREAS, the President's vision as espoused in the Philippine Development Plan (PDP) 2011-2016 is to achieve inclusive growth – rapid and sustained environment that creates jobs and continuously reduces mass poverty;

WHEREAS, corollary to PDP's policy on good governance is a national declaration and campaign for people's engagement in local governance thus, LGUs are encouraged to create opportunities for citizens to continuously engage with them in an inclusionary and participatory manner such as the implementation of local government's development projects, among others;

WHEREAS, the DILG through its Performance Challenge Fund provided financial incentives to local government units that were committed in valuing the fundamentals of good governance by meeting the requirements of the Seal of Good Housekeeping;

WHEREAS, the Municipality of Itogon is recipient of the 2017 Seal of Good Local Governance and is granted a PCF in the amount of Two Million Pesos (Php 2,000,000.00);

WHEREAS, as stated in the DILG MC No. 2017-160 dated November 29, 2017 re: Operational Guidelines on the Implementation of 2017 Performance Challenge Fund, one of the required documents in accessing the PCF is the creation of an LGU PCF Project Implementation Team;

NOW, THEREFORE, I, ATTY. VICTORIO T. PALANGDAN, by virtue of the powers vested in me by law as Municipal Mayor of Itogon, Benguet, do hereby reorganize the LGU PCF Project Implementation Team;
