



**ADMINISTRATIVE ORDER NO. 10**

**RECONSTITUTING THE MUNICIPAL DEVELOPMENT COUNCIL.**

**WHEREAS**, Book I, Title Six of the Local Government Code, provides for the creation and composition of Local Development Councils in provinces, cities, municipalities and barangays;

**WHEREAS**, the expiration of the term of office of all Punong Barangays last June 30, 2018 and the result of the May 14, 2018 Barangay and SK Elections necessitates a reorganization of the local development council as far as mandatory membership of the Punong Barangays is concerned;

**WHEREAS**, in view of the foregoing developments, it is imperative to reconstitute the Municipal Development Council to include in its membership the re-elected Punong Barangays, the newly-elected Punong Barangays in lieu of their respective predecessors, and to include therein other representations from Civil Society Organizations.

**NOW THEREFORE**, by virtue of the powers vested in me by law, I, **ATTY. VICTORIO T. PALANGDAN**, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby ORDER as follows:

**Section 3. Duties and Functions.** The duties and functions of the Municipal Development Council and its secretariat as provided under the Local Government Code and reiterated under Administrative Order No. 10-13-N shall remain and shall form an integral part of this order. Provided further, that in accordance with Article 182 (g) (3) of the implementing rules and regulations of the code, the duties and functions of the sectoral committees shall:

1. Provide the MDC with data and information essential to the formulation of plans, programs and activities;
2. Define sectoral or functional objectives, set targets, and identify programs, projects, and activities for the particular sector or function;

3. Collate and analyze information and statistics and conduct related studies;
4. Conduct public hearings on vital issues affecting the sector or function;
5. Coordinate planning, programming, and implementation of programs, projects and activities within each sector;
6. Monitor and evaluate programs and projects; and
7. Perform such other functions as may be assigned by the MDC.

**Section 4. Repealing Clause.** Administrative Order No. 32, series of 2016 is hereby repealed and rendered of no force and effect. All Administrative Orders and executive issuances inconsistent herewith are hereby deemed repealed accordingly.

**Section 5. Effectivity.** This Order shall take effect immediately.
