**REORGANIZING THE MUNICIPAL CLEAN AND GREEN COMMITTEE OF THE LOCAL GOVERNMENT OF ITOGON**

**WHEREAS**, cognizant of the rights of our people to a balanced and healthful ecology in accordance with the rhythm of nature laid down in our constitution and further strengthened by subsequent laws and issuances, the municipal government is actively involved in planning and implementation of projects, programs and activities consistent with local, national and international initiatives that aim to protect and preserve the environment, sustain life and safeguard the health and well-being of our people;

**WHEREAS**, the Municipal Clean and Green Committee was created to oversee the implementation of clean, green and bloom activities in the municipality and its component barangays including similar activities of the Provincial Government and other participating agencies and offices;

**NOW THEREFORE**, by virtue of the powers vested in me by law, I, **ATTY. VICTORIO T. PALANGDAN**, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby promulgate as follows:

**Section 2. Duties and Functions.** The Municipal Clean and Green Committee shall perform the following functions:

1. Shall be the front liner in the implementation of clean, green and bloom programs and activities in the municipality. As such, the committee shall encourage the participation of all stakeholders in this collective effort.
2. In coordination with the MESWMB-TWG, develop plans and strategies to maintain clean and green environment consistent with the principle of sustainable development;
3. Develop a program on awards and incentives in recognition of a community or barangay that demonstrates exemplary actions for the promotion of a clean, healthy and green environment subject to auditing rules and regulations;
4. Assist barangays, schools, and other institutions within the municipality participating in the provincial, regional and national clean and green competitions and such similar competitions organized by public or private entities;
5. Assist representatives of the Provincial Government in the conduct of assessment and evaluation of barangays, schools, etc. representing the municipality to the clean, green and bloom competition; and
6. Perform such other duties and functions pursuant to law or ordinance, or as may be directed by the Local Chief Executive.
