DESIGNATING THE MEMBERS OF THE MUNICIPAL ADVISORY COMMITTEE ON POLICE TRANSFORMATION AND DEVELOPMENT AND PERFORMANCE GOVERNANCE SYSTEM (MAC-PTD-PGS) OF THE MUNICIPALITY OF ITOGON.

WHEREAS, the Peace and Order Agenda of Transformation and upholding of the Rule of Law Plan 20130 (otherwise known as P.A.T.R.O.L. Plan 2030) was developed as part of the national government's innovation to transform the image of the PNP and improve the quality of its services, making it a world-class organization with proficient and professional personnel;


