ADMINISTRATIVE ORDER NO. 08

DESIGNATING MS. IRENE F. FERNANDO, ACTING MUNICIPAL TREASURER AS MEMBER OF THE DIFFERENT LOCAL SPECIAL BODIES, COMMITTEES, COUNCILS, BOARDS AND SUCH OTHER BODIES CREATED UNDER THE MUNICIPAL GOVERNMENT WHEREIN THE MUNICIPAL TREASURER IS A MEMBER THEREOF IN LIEU OF MS. ANGELA C. CARIÑO WHO WAS SEPARATED FROM SERVICE BY REASON OF HER RETIREMENT.

WHEREAS, a vacancy occurred in various local special bodies, committees, councils, boards, etc. which were created and/or established under the municipal government of which the Municipal Treasurer is a member due to the retirement of Ms. Angela C. Cariño;

WHEREAS, in the exigency of service, the Department of Finance through the Bureau of Local Government Finance designated Ms. Irene F. Fernando as Acting Municipal Treasurer of the Municipality of Itogon effective April 21, 2022;

WHEREAS, the vacancies arising from the separation of Ms. Angela C. Cariño from government service necessitate the immediate designation of her successor in the various local bodies, committees, boards, and the like, to prevent delay in the delivery of related government services and to ensure continuity in the execution of functions appurtenant thereto;

NOW THEREFORE, by virtue of the powers vested in me, I, ATTY. VICTORIO T. PALANGDAN, in my capacity as Municipal Mayor of Itogon, Benguet Province, hereby ORDER as follows;

Section 1. In the exigency of services for the public good, MS. IRENE F. FERNANDO, Acting Municipal Treasurer of Itogon is hereby designated as member of the different Local Special Bodies, Boards, Committees and such other bodies created under the Municipal Government where the Municipal Treasurer is among its members;

Section 2. the position of the Municipal Treasurer in Local Special Bodies, Committees, Councils, and Boards duly created shall be occupied by the Acting Municipal Treasurer unless provided otherwise under subsequent laws and issuances, or unless a reorganization shall take place by virtue of an ordinance or through a subsequent order to be issued by the undersigned;

Section 3. All Administrative Orders or parts thereof inconsistent herewith or parts hereof are deemed repealed and/or modified accordingly.

Section 4. This Administrative Order shall take effect immediately.
