REORGANIZING THE MUNICIPAL INTER-AGENCY MONITORING TASK FORCE TO MONITOR AND EVALUATE THE FUNCTIONALITY OF THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN.

WHEREAS, the Department of the Interior and Local Government issued Memorandum Circular No. 2021-039 or the "Comprehensive Guidelines for the Establishment, Strengthening and Monitoring of the Local Council for the Protection of Children at all Levels and for Other Purposes;"

WHEREAS, the aforementioned Memorandum Circular directs the creation of an Inter-agency Monitoring Task Force in all levels of the municipality/city, province/highly urbanized cities and region, providing for the composition and functions thereof;

NOW THEREFORE, by virtue of the powers vested in me as Local Chief Executive, I, **BERNARD S. WACLIN**, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby ORDER as follows, to wit;

Section 1. There is hereby reorganize the Municipal Inter-agency Monitoring Task Force (MIMTF) in the Municipality of Itogon, the composition of which are as follows:

Section 2. The MIMTF shall perform the following functions:

- Gather, collect and organize the required documents as provided in item 5.6.4.1 of DILC MC No. 2021-039 from the Barangay Council for the Protection of Children every 15th day of February of the assessment year;
- Review the documents and evaluate the BCPC using LCPC Assessment Form 001-A hereto attached and marked as annex "A" to form part of this order;
- Meet with concerned barangay officials for feedback giving on the strength/weaknesses of the BCPC; and
- 4. Using the LCPC Consolidated Form 001-A, shall submit report to the Provincial IMTF in soft and hard copies on or before March 15 of the assessment year, copy furnished the DILG Municipal Office.

Section 3. The MIMTF may call upon the secretariat of the LCPC to assist the former in the performance of its functions.

Section 4. All Administrative Orders or parts thereof inconsistent herewith or parts hereof are deemed repealed and/or modified accordingly.

Section 5. This Order shall take effect immediately.
