**AN EXECUTIVE ORDER CREATING THE MUNICIPAL CENSUS
 COORDINATING BOARD**

WHEREAS, Republic Act (RA) No. 10625, also known as the Philippine Statistical Act of 2013, states that the Philippine Statistics Authority (PSA) shall prepare and conduct periodic censuses on population, housing, agriculture, fisheries, business, industry and other sectors of the economy;

WHEREAS, Executive Order No. 253 entitled "Designation of Statistical Activities that will Generate Critical Data for Decision-Making of the Government and the Private Sector" stipulates the conduct of a mid-decade census primarily to update the population count in all barangays nationwide;

WHEREAS, DILG-MC No. 2015-39 enjoins all Local Government Units to provide support in the conduct of the 2015 Census of Population (POPCEN 2015) this August 2015 with August 1 as reference date;

WHEREAS, to ensure the successful conduct of the census, the PSA approved Resolution No. 09 prescribing the composition and terms of reference (TOR) of the Municipal Census Coordination Boards (MCCBs) but without limitation to the composition whereby the composition is expanded to best achieve the intended result;

NOW THEREFORE, by virtue of the powers vested in me, **I, ATTY. VICTORIO T. PALANGDAN**, Municipal Mayor of Itogon, Benguet, hereby create the Municipal Census Coordinating Board to be composed of the following:

- b) Formulate strategic plans for the implementation of a public information campaign to encourage the citizenry, to support and cooperate in the POPCEN 2015 by providing complete and correct information to census enumerators.
- c) Monitor the conduct of POPCEN 2015 in the municipality.
- d) Coordinate with the concerned agencies for the implementation of the POPCEN 2015 to ensure its success like the previous undertakings.

This Executive Order shall take effect immediately this **25th day of May 2015**.
