**REORGANIZING THE MUNICIPAL ADVISORY COMMITTEE ON POLICE TRANSFORMATION AND DEVELOPMENT AND PERFORMANCE GOVERNANCE SYSTEM (MAC-PTD-PGS) IN THE MUNICIPALITY OF ITOGON.**

**WHEREAS**, the Peace and Order Agenda of Transformation and upholding of the Rule of Law Plan 20130 (otherwise known as P.A.T.R.O.L. Plan 2030) was developed as part of the national government's innovation to transform the image of the PNP and improve the quality of its services, making it a world-class organization with proficient and professional personnel;

**WHEREAS**, various units performing corresponding tasks were organized under the P.A.T.R.O.L. Plan 2030 among which is the Center for Police Strategy Management under which the Performance Governance System is attached;

**WHEREAS**, the Performance Governance System requires for the establishment of Multi Sectoral Governance Councils composed of sectoral leaders or individuals known for their integrity, probity and leadership, among which is the Municipal Advisory Council which functions are focused on the successful implementation of the strategic transformation road map as defined in the plan;

**WHEREFORE**, by virtue of the powers vested in me by law, I, **ATTY. VICTORIO T. PALANGDAN**, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby reorganize the Municipal Advisory Council for Itogon Municipal Police Station which shall be hereafter known as Municipal Advisory Council on Police Transformation and Development, and Performance Governance System (MAC-PTD-PGS), the composition, duties and functions of which and other relevant provisions are herein provided, to wit;

**Section 1. Composition.** The Municipal Advisory Committee on Police Transformation and Development and Performance Governance System (MAC-PTD-PGS) shall be composed of the following:

- Chairman: The Municipal Mayor
- Vice Chairman: The Municipal Vice Mayor
- Members: Chairman, Comm. on Peace and Order, S.B DILG-MLGOO.

- President, Liga ng mga Barangay
- President, SK Federation
- Representatives from the following sectors:

- Business Sector
- Religious Sector
- Women's Sector
- Senior Citizens' Sector
- Academe/Education Sector
- Media
- Public Attorney's Office
- Itogon Developers and Contractors Assn.

**Section 2. Functions.** Consistent with the P.A.T.R.O.L. Plan 2030, the MAC-PTD-PGS shall perform the following functions:

1. Advise and assist the Itogon Municipal Police Station in identifying key priorities and strategic issues in line with PNP PATROL Plan 2030, and provide insights in aligning the PNP's policies, plans and programs with the political, socio-economic, cultural and moral development needs of the municipality;
2. Assist the IMPS in resource generation and mobilization to enable members of the PNP to effectively perform their duties and functions of maintaining peace and order in the locality and in pursuance of their strategic priorities as laid out in the PATROL PLAN 2030;
3. Initiate forums and similar activities for purposes of formulating a multi-sectoral coalition that would heighten linkages between the PNP, the community and all stakeholders;
4. Conduct periodic assessment on the performance and functionality of the IMPS and shall inform the latter on the result of such assessment for its analysis in order to enable our local police force to identify their strengths and weaknesses with the end view of bringing back the good image of the law enforcement agency;
5. Perform other related functions as may be directed by law or ordinance.

**Section 3. Meetings and Quorum.** On its first meeting, the MAC-PTD-PGS shall fix the schedule of its regular meetings which shall not be less than once in every three months of the year. Provided further that in cases where urgent matters have to be considered, a Special or Emergency Meeting may be called upon by the Chairman or by majority of the members. A simple majority of all members shall constitute a quorum to transact official business.

**Section 4. Separability Clause.** If for any reasons, this Order or parts hereof are declared invalid or unconstitutional by competent authority, parts hereof not affected thereby shall continue to be in force and effect.

**Section 5. Repealing Clause.** All Executive Orders and/or Issuances inconsistent herewith or parts hereof are deemed repealed and/or modified accordingly.

**Section 6. Effectivity.** This Executive Order shall take effect immediately.
