**IMPLEMENTATION OF INNOVATIVE MEASURES TO ENSURE SOCIAL DISTANCING AND BASIC INFECTION PREVENTIVE STRATEGIES UNDER ENHANCED COMMUNITY QUARANTINE IN ITOGON, BENGUET**

Whereas DILG Secretary EDUARDO M. AÑO issued an ADVISORY dated April 18, 2020, regarding social distancing and basic infection prevention measures under community quarantine;

Whereas the advisory strongly urged Local Government Units to discontinue the imposition of narrow or limited window period on the access to and operations of public and private establishments such as wet markets, supermarkets, grocery stores and pharmacies;

Whereas the advisory further enjoined LGUs to implement innovative measures to bring market/goods closer to the people, subsequently limiting people's movement and ensuring social distancing;

Now therefore, by virtue of the powers vested in me as the Local Chief Executive of the Municipality of Itogon, I, Atty. Victorio T. Palangdan, do hereby order:

Section 1: As an innovative measure, Punong Barangays of all the nine barangays of Itogon are enjoined to implement the;

- a) MARKET ON WHEELS or MOBILE PALENGKE, where vehicles with market goods would strategically be deployed to residential communities. This shall be done in coordination with the Municipal Agriculture Office and Department of Trade and Industry – Baguio/Benguet Field Office.
- b) Online Marketing and delivery of goods through the use of various on-line platforms

Section 2: To lessen the number of people from the municipality going to Baguio City for the purpose of purchasing food, goods and other basic necessities, Punong Barangays shall devise means so that those issued quarantine pass shall be allowed once or twice a week only to travel to Baguio City.

Section 3: Barangay officials shall strictly observe the schedule of allowed trips of public utility vehicles as well as private vehicles to Baguio City pursuant to the directive issued by the Baguio City Local government, with the strict implementation of social distancing.

Section 4: This Executive Order shall take effect immediately.
