ORGANIZING THE ITOGON VALUES FORMATION COUNCIL

Whereas the Sangguniang Bayan enacted Municipal Ordinance No. 049, s.2021, entitled: "INSTITUTIONALIZING A MORAL ENHANCEMENT AND RECOVERY PROGRAM IN THE MUNICIPALITY OF ITOGON AND CREATING THE ITOGON VALUES FORMATION COUNCIL";

Whereas the above-said ordinance was duly given favorable review by the Sangguniang Panlalawigan of Benguet as embodied in SP Resolution No. 2021-50 dated February 8, 2021;

Now therefore by virtue of the powers vested in me by law as the Local Chief Executive of the Municipality of Itogon and pursuant to the provisions of Itogon Municipal Ordinance No. 049,s.2021, I, Atty. VICTORIO T. PALANGDAN, do hereby ORDER the following:

Section 2. FUNCTIONS OF THE ITOGON VALUES FORMATION COUNCIL.

The functions of the IVFC shall be the following:

- a) Shall formulate moral enhancement program and value development plans and programs in the Municipality.
- b) Determine the needs of municipal employees and stakeholders which have an effect in their morale and level of spiritual and psychological fulfillment.
- c) Monitor the progress of the implemented moral recovery programs in the municipality.

Section 3. REGULAR MEETING. The IVFC shall hold its regular meeting on every last Friday of the last month of every quarter.

Section 4. SPECIAL MEETING. A special meeting of the IVFC may be held if necessary as determined by the Chairperson.

Section 5. SEPARABILITY CLAUSE. If any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

Section 6. EFFECTIVITY. This Executive Order shall take effect immediately.
