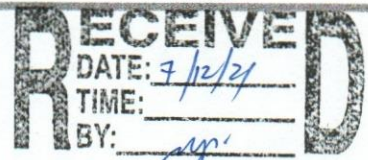

RE-ORGANIZING THE COMPREHENSIVE LAND USE PLAN (CLUP) AND ZONING ORDINANCE PLANNING TEAM CORE GROUP AND TECHNICAL WORKING GROUP

WHEREAS, Sec. 20c of the Local Government Code of 1991 (RA 7160) mandates the preparation of LGU's Comprehensive Land Use Plans enacted through Zoning Ordinances which shall be the primary and dominant bases for future use of land resources;

WHEREAS, Executive Order NO. 72 mandates all LGU to update their Comprehensive Land Use Plans in conformity with the land use planning standards and guidelines prescribed by the Housing and Land Use Regulatory Board (HLURB) and to national policies;

WHEREAS, the Urban and Development Housing Act (UDHA) or RA 7279 gives a clear-cut definition of a Land Use Plan which the LGUs are mandated to adopt;

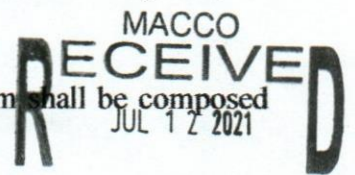
WHEREAS, from 2015 to present, various physical development regarding use of land resources which are to uplift and improve the quality of life of the people of Itogon are necessary, thus there is a need to update the CLUP;

NOW THEREFORE, I, ATTY. VICTORIO T. PALANGDAN, Municipal Mayor of the Municipality of Itogon, Province of Benguet, by virtue of powers vested in me by law, do hereby order and direct the following:

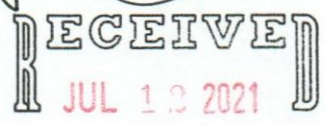
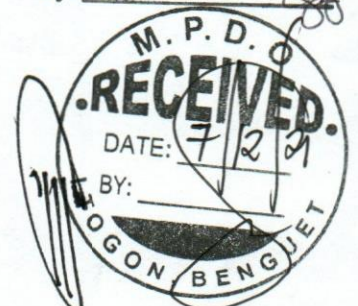
