



**EXECUTIVE ORDER NO 15**  
**Series of 2021**

**ORDERING THE IMPOSITION OF GRANULAR LOCKDOWN OVER SITIOS BAGUENG AND KERENG OF BARANGAY TINONGDAN EFFECTIVE 12:00 IN THE MORNING OF OCTOBER 25, 2021 UNTIL FURTHER NOTICE.**

WHEREAS, the increase in number of COVID-19 positive cases in Sitios Bagueng and Kereng, both of barangay Tinongdan, this municipality requires the implementation of drastic measures to contain the spread of the virus in the vicinities of these areas and in order to prevent widespread of cases in the locality;

WHEREAS, the implementation of a granular lockdown in the aforementioned sitios shall enable our concerned personnel to efficiently conduct contact tracing, isolation and disinfection;

NOW THEREFORE, by virtue of the powers vested in me as the Local Chief Executive of the Municipality of Itogon, in accordance with law, rules and regulations, I, ATTY. VICTORIO T. PALANGDAN, do hereby ORDER as follows:

Section 1. Granular Lockdown is hereby imposed at Sitio Bagueng and Sitio Kereng, both within Barangay Tinongdan effective 12:00 AM of October 25, 2021 until further notice as may be recommended by the Municipal Health Officer in coordination with the Punong Barangay of Tinongdan.

Section 2. The Punong Barangay concerned shall strictly implement this order over the sitios aforementioned and shall coordinate with the Municipal Health Office for the conduct of contact tracing, isolation and disinfections; to the Municipal Social Welfare and Development Office for the provision of food and essential supplies to those affected; to the IMPS for the provision of personnel to secure the areas and assist in the implementation of CURFEW from 9:00 in the evening to 5:00 of the following morning; and to all other concerned agencies/offices for the provision of other assistance to address immediate needs of residents;

Section 3. Authorized Persons Outside Residence (APOR) shall be allowed entry and exit at established quarantine checkpoints upon presentation of pertinent Identification Cards or any similar documents;

Section 4. At the duration of the granular lockdown, retail stores within the affected areas selling food, over-the-counter medicines and other basic household necessities may be allowed to operate to cater to the needs of the affected residents within the premises of the sitio subject to the strict observance of minimum health standards and liquor ban with the prohibition of by-standing at the store premises. Provided further that operations of all recreation areas or amusement centers is hereby suspended. Such establishment shall include billiard halls, videoke bars, etc.

Section 5. This Order shall take effect immediately.
