EXECUTIVE ORDER NO. 03

REORGANIZING THE COMPOSITE TEAM TO CONDUCT THE DELINEATION OF THE METES AND BOUNDS OF THE COMMUNAL FORESTS ESTABLISHED IN THE MUNICIPALITY.

WHEREAS, there are three (3) communal forests established in the Municipality of Itogon, which are located in two different barangays and more particularly known as follows:

- a. Parcel II(CnF1829)- Apalan Communal Forest located at Apalan, Loacan, Itogon, Benguet w/ total area of 13 has.(FAO No.2-1315 dated February 16, 1940:
- b. Parcel III(CnF1830) -Lucbuban Communal Forest located at Lucbuban, Itogon, Benguet w/ total area of 49 has.(FAO No.2-1154 dated 12/14/1938); and
- c. Parcel I(CnF1737)-Tocmo Communal Forest located at Tocmo Loacan, Itogon, Benguet w/ total area of 8 has.(FAO No.2-1216 dated 2/16/1940).

WHEREAS, to ensure the perpetual existence of these communal forests for the benefit and enjoyment of the present and future generations, it is imperative for the government most especially for the concerned local government units to initiate appropriate actions for its preservation and protection against encroachments and other forms of external aggregations;

WHEREAS, in order to identify the extent of the area covered by these communal forests, it is necessary that its metes and bounds be first established on ground along with the installation of permanent markers or monuments on each and every corner thereof;

WHEREAS, the Department of Environment and Natural Resources through its CAR Regional Office and the Municipality of Itogon are pursuing collaborative actions for the protection and preservation of the communal forests hence, the creation of a composite team from the MENRC to provide the necessary administrative support and manpower requirements to its counterparts from the DENR;

WHEREAS, in pursuance of the spirit and intent of the creation of the composite team, it is imperative to reorganize the same to ensure continuous functionality and uninterrupted actions toward the implementation of the plans and programs under the collaboration;

NOW THEREFORE, by virtue of the powers vested in me, I, HON. BERNARD S. WACLIN, in my capacity as Municipal Mayor of Itogon, Benguet Province, hereby ORDER as follows;
