REORGANIZING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) OF THE MUNICIPALITY OF ITOGON, DESIGNATING ITS MEMBERS AND FOR OTHER PURPOSES.

WHEREAS, the enactment of the Disaster Risk Reduction and Management Act of 2010 otherwise known as RA 10121 empowered Local Government Units and the Civil Society Organizations as key partners in disaster risk reduction. It further transformed the country's method of management system from disaster relief and response towards disaster risk reduction;

WHEREAS, the DRRM Act mandates the creation of Municipal Disaster Risk Reduction and Management Council in the municipalities, providing for its composition and defining the functions thereof;

WHEREAS, the occurrence of vacancies in the membership of the MDRRMC due to significant events necessitates the reorganization of said body to provide opportunity to the affected sectors, agencies, or offices to be represented by filling up the vacant positions with its corresponding representative;

NOW THEREFORE by virtue of the powers vested in me as Municipal Mayor of the Municipality of Itogon, I, BERNARD S. WACLIN hereby reorganize the Municipal Disaster Risk Reduction and Management Council (MDRRMC) of the Municipality of Itogon as follows:

Section 2. Duties and Functions. In accordance with RA 10121, the functions of the MDRRMC shall be as follows:

1. Approve, monitor and evaluate the implementation of the Local Disaster Risk Reduction and Management Plan (LDRRMP) and annually review, test and develop the plan consistent with other national and local planning programs;
2. Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;
3. Recommend the implementation of forced or preemptive evacuation of local residents, if necessary;

4. Convene the local council as provided under RA 10121 and its implementing rules and regulations; and
5. Perform such other related functions as may be provided by law or ordinance.

Section 3. The Executive Committee, Composition. There is hereby created an Executive Committee which shall be composed of the following:

Section 7. Effectivity. This Order shall take effect immediately.
