**REORGANIZING THE LUPONG TAGAPAMAYAPA MUNICIPAL
AWARDS COMMITTEE (LTMAC)**

WHEREAS, Section 406 (b) of RA No. 7160 or the Local Government Code states that the DILG shall provide a system of granting economic or other incentives to the Lupon or pangkat members who adequately demonstrate the ability to judiciously and expeditiously resolve cases referred to them;

WHEREAS, the Lupon Tagapamayapa Incentives Awards (LTIA) was conceptualized and implemented in 1982 and has been elevated to a Presidential Award pursuant to Executive Order No. 394 s. 1997 entitled “Establishing the Lupon Tagapamayapa Incentives Awards”;

WHEREAS, the LTIA is an annual search which recognizes the outstanding lupon tagapamayapa that adequately demonstrates the ability to judiciously and expeditiously resolve cases referred to them and demonstrate exemplary performance and commendable contribution in the promotion and implementation of Katarungang Pambarangay;

WHEREAS, DILG Memorandum Circular No. 2023-022 provided for Lupon Tagapamayapa Awards Enhanced Criteria and Guidelines including the composition of the different awards committees ;

WHEREAS, by virtue of the powers vested in me by law, I, HON. BERNARD S. WACLIN, Municipal Mayor of the Municipality of Itogon, Benguet Province, hereby reorganize the Lupon Tagapamayapa Municipal Awards Committee (LTMAC), as follows:

Section 1. Composition. The Lupon Tagapamayapa Municipal Awards Committee (LTMAC) shall be composed of the following:

Section 2. Functions:

1. Initiate and coordinate the necessary activities toward the successful implementation of the LTIA in their respective level;
2. Disseminate information on the Awards to generate awareness and support from the public and private sectors in their respective region;
3. For the Municipal Assessment Committee (MAC) to select and submit to the Provincial Assessment Committee (PAC) the best performing Lupons within the municipality;
4. Secure funding and counterpart prizes from the partner agencies and private sector;
and
5. Plan and implement appropriate awarding ceremonies

The DILG Municipal Office shall provide technical and secretariat services to the MAC.

Section 3. Repealing Clause. All Administrative Or Executive Orders or parts thereof which are inconsistent with this order or parts hereof are deemed repealed or modified accordingly.

Section 4. Effectivity. This executive order shall take effect effectively.
