



**EXECUTIVE ORDER NO. 15**  
Series of 2024

**SUSPENSION OF WORKS IN ALL GOVERNMENT OFFICES IN THE MUNICIPALITY OF ITOGON INCLUDING PUBLIC AND PRIVATE SCHOOLS FROM PRESCHOOL TO SENIOR HIGH SCHOOL LEVELS TODAY, JULY 25, 2024.**

**WHEREAS**, due to heavy rainfalls and strong winds affecting the entire municipality, the Local Chief Executive issued Executive Order No. 14, series of 2024 suspending works in all government offices in the Municipality of Itogon including public schools for half day since 12:00 noon of July 24, 2024;

**WHEREAS**, continuous heavy rainfall due to the enhanced southwest monsoon caused by Typhoon Carina is being experienced in the entire locality, triggering rain-induced hazards such as landslides, mudflow, flash floods and flooding as well as rise in water level in our major river systems;

**WHEREAS**, it is necessary to continue implementing preemptive measures to ensure the safety of our residents by encouraging them to stay home and to stay vigilant in order to prevent any untoward incident and avoid impending hazards associated with this extreme weather condition;

**NOW THEREFORE**, by virtue of the powers vested in me, I, **HON. BERNARD S. WACLIN**, in my capacity as Municipal Mayor of Itogon, Benguet Province, hereby **ORDER** as follows;

**Section 1.** All works in government offices including public and private schools at all levels in the Municipality of Itogon are hereby **SUSPENDED** today, July 25, 2024 with the exception of the Philippine National Police and other similar law enforcement agencies duly assigned in this municipality.

**Section 2.** Personnel of the MDRRMO are **DIRECTED** to report to the Emergency Operations Center and shall **CONTINUE TO BE ACTIVE** under **RED ALERT STATUS** in anticipation of any threats and possible effects of this severe weather disturbance and shall continue to undertake surveillance, monitoring, coordinated response and assessment activities. All Barangay DRRM Committees are likewise directed to activate their respective Operations Centers in accordance with this Order.

**Section 3.** The Municipal Health Office and the Municipal Social Welfare and Development Office are likewise instructed to provide necessary assistance to the MDRRMO to ensure timely delivery of appropriate services to our constituents.

**Section 4.** This Executive Order shall take effect immediately.
